

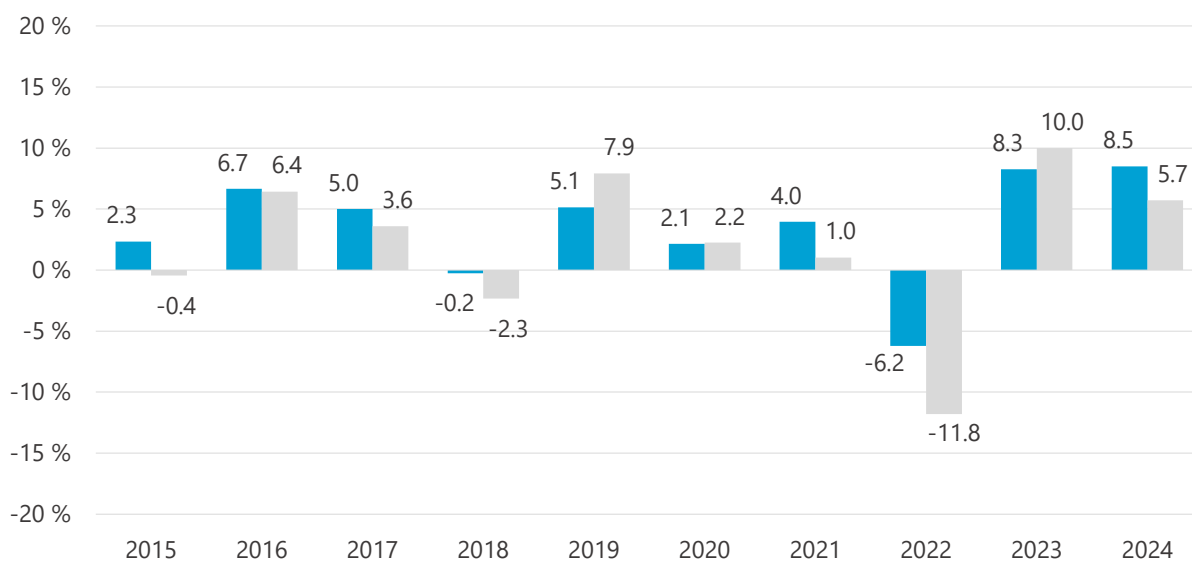
Mutual Fund LocalTapiola Northern Corporate Bond

Share class and date of inception: accumulation (A) 7 October 2013, income (B) 7 October 2013

Benchmark: In performance reporting the fund is compared with a combination of the indices iBoxx Euro Corporates Overall Performance (50 %) and iBoxx EUR Liquid High Yield TR (50 %). iBoxx Euro Corporates Overall Performance (50 %) and iBOXX EUR Liquid High Yield (50 %) until 30 April 2020.

The past performance is presented through the accumulation unit (A) of the fund, where any distributable investment return of the fund has been reinvested.
