

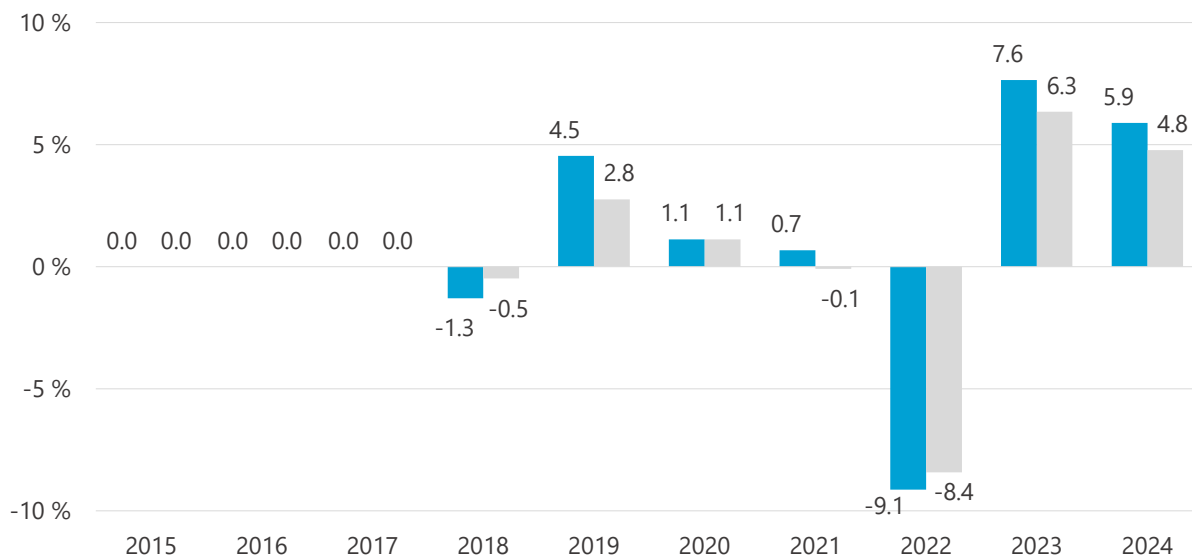
Mutual Fund LocalTapiola Institution Corporate Bond IV

Share class and date of inception: Share unit IV accumulation (A) 1 January 2024, income (B) 15 June 2017

Benchmark: In performance reports the fund is compared with the iBoxx Euro Corporates 1–5 TR index. 10 % iBoxx € Financials TR 1-3 + 10 % iBoxx € Financials TR 3-5 + 80 % iBoxx € Non-Financials TR 1-5 until 31 December 2017.

The past performance is presented through the accumulation unit (A) of the fund, where any distributable investment return of the fund has been reinvested. The return history of the share unit is presented from 15 June 2017 to 31 December 2023 through the fund's income unit (B) adjusted for payment of income.

This chart shows the fund's performance as the percentage loss or gain per year over the last 7 years against its benchmark. It can help you to assess how the fund has been managed in the past and compare it to its benchmark.
